This is an informational document proposing that the GAC adopt a set of communication guidelines to be used by the GAC and its subcommittees to avoid Brown act violations. This will be presented as information material and discussed at the 3/14/22 GAC meeting and then revised based on the discussion. Following revision it will be presented to the GAC for approval.

# Proposed Informational Communication Policy for the GAC and Its Subcommittees

- 1. To avoid group emails sent to the GAC or subcommittee members being accidentally replied to with a "reply all", thus possibly violating the Brown act, any informational email sent to the entire GAC, an entire subcommittee, or the extended GAC communication list should have all email addresses other than the sender listed as "BCC". The member sending the email will send the email "TO" themself. Emails asking for subcommittee meeting availability or other focused subcommittee business may be sent to all subcommittee members without using a BCC.
- 2. A presentation of the implications of the Brown Act and how they relate to the GAC will be discussed at beginning of each GAC term by the golf division staff. This will ensure every member of the GAC has a clear understanding of the Brown Act.
- 3. Announcements of GAC or subcommittee meetings, along with the agenda and any documents that will be discussed at the meeting, should be sent to the Golf Division at least 72 hours prior to the meeting with a request to post the meeting notice on the GD or GAC website and at the city courses...

- 1. Plans for 2022 LA City Women's Golf Championship June 24, 25 & 26 at Wilson and Harding
  - Chuck Ruiz said GD had already made Championship Division a 3-day tournament
    - Most likely will have a down-select after 36 holes.
  - Timeline of events leading up to Women's Championship.
    - o Poster should be available early April; will post at junior championship
    - Start and end of sign-up Starts early April; ends a week or 2 before
    - Tee gift will be custom driver cover, 4 different colors, Championship Logo
    - Need a minimum of 4 to 6 volunteers each of 3 days; more volunteers will allow more positions and split shifts
    - Volunteers should contact GD early June
  - All GAC members should check their course to make sure poster for Junior Championship is up. Junior Championship is for girls and boys 7 to 18 (if still in high school).
    - Volunteers needed, especially for youngest group (walking scorers)
  - How to notify more golfers of championship
    - GAC clubs should send "save the date" now; GD will send out save the date, and will send more than once. Should try to get other golf organizations to do the same.
    - Ideally, GAC would contact board of directors for all clubs in LA County, with info on Championship
    - SCGA cannot give us roster of all clubs, but might be convinced to give us name of golf courses, and or clubs, or to contact all of them on behalf of city
    - Lew Murez runs Pasadena championship
    - Should advertise that there will be flights in Net and Seniors divisions if enough people sign up.
    - Need contacts for all public courses and private clubs in LA County
      - Debra Meymarian will get a list of contacts from Industry Hills
    - Nikki Gatch is new president of the board of directors of SCGA and is very interested in promoting women's golf.
    - Stephanie Tran is SCGA's new Manager of Championships and Golf Operations. Debra Meymarian knows her and will talk to her about LA Championship
    - Would like notice in ForHer to be more prominent
- 2. Creation of city-wide weekend club for women to be discussed at next GAC meeting

- Should non-city courses be considered?
- GAC members should get data on city clubs: How many clubs are coed, and how friendly
  are they to women? How are tee assignments determined? What method is used for
  comparing score for men and women playing from different tees?
- Women's clubs are allowed to substitute six (6) weekday tournaments to conduct six (6) weekend tournaments on their home course. The fee for weekend tournaments is the weekend rate.
- Each Women's Club is allowed no more than six (6) additional reservations per calendar year.
- 3. Other topics to be considered for discussion this year
  - Women's Golf Day June 7 (event at Griffith organized by GPGC)
  - Are any other city clubs organizing events?
